The University of Suffolk Students' Union is a charity and membership organisation which represents and supports over 14,000 students studying at our Ipswich campus and across the UK and overseas.

We are student-led and provide a range of services and opportunities to students including representation, advice, events, sports, social activities, and training. Alongside this we also operate a social space and shop on our Ipswich campus.

The Students' Union is led by our two elected student Presidents and is overseen by our Board of Trustees, with day-to-day operations and strategic management delegated to the Chief Executive.

JOB DESCRIPTION & PERSON SPECIFICATION

Position title	Student Trustee
Department	Board of Trustees
Reports to	Chair of the Board / Chief Executive Officer
Term length	Up to 2 years commencing from May 2026 (as long as a current student)
Time commitment	Approximately 4–6 Board meetings per year, plus training, preparation time and occasional subcommittees
Paid or voluntary role	Voluntary

ABOUT THE ROLE

As a Student Trustee at the University of Suffolk Students' Union (UoSSU), you'll help steer the long-term and strategic direction of the Union, making sure it stays student-led, sustainable, and impactful.

You'll work alongside other student, external, and officer trustees as part of the Board of Trustees – the Union's highest decision-making body.

The Board is responsible for overseeing the charity's finances, legal compliance, and long-term goals. Your voice as a current student is essential in ensuring the Union truly reflects and works in the best interests of Suffolk students.

This is a fantastic opportunity to develop leadership experience, get involved in high-level decision-making, and influence positive change for your peers.

You'll be a full member of the Board, with equal say in decision-making and governance, and your insights as a current student are essential in ensuring the Union remains student-led.

The Board of Trustees meets 4-6 times per year, some of which take place online and some in person on the Ipswich Campus.

SUPPORT AND TRAINING

All student trustees will receive training regarding the role of a trustee on a Board of Trustees for a charity.

Support will be provided throughout time in role by the Chair of the Board of Trustees, and other external trustees and the Chief Executive Officer where appropriate.

KEY RESPONSIBILITIES

- 1 Attend and actively contribute to all Board of Trustee meetings.
- 2 Ensure the Union is meeting its charitable objectives and acting in the best interests of its members.
- 3 Scrutinise the Union's finances, risk register and strategic plans.
- 4 Bring a student voice to the Board, highlighting real student experiences and needs.
- 5 Work collaboratively with other trustees and senior SU staff to help the Union thrive.

WHAT YOU'LL GAIN

- 1 Experience of governance and charity boards - great for your CV!
- 2 Insight into strategic leadership and high-level decision making.
- 3 Skills in strategic thinking, networking and financial understanding.
- 4 Confidence in speaking in formal meetings and working alongside professionals from elsewhere in industry.
- 5 A chance to shape the future of the Students' Union and student experience here at Suffolk.

PERSON SPECIFICATION

ESSENTIAL

- 1 Must be a current student at the institution (undergraduate or postgraduate). You can no longer be a student trustee once graduated.
- 2 Willingness to commit time to training for the role, preparation for meeting, reading papers and attending meetings.
- 3 Strong communication and teamwork skills.
- 4 Willingness to learn about charity governance and responsibilities.
- 5 Ability to think critically and ask questions from a student point of view regarding the business of the Board of Trustees.

DESIRABLE

- 1 Awareness of the work of University of Suffolk Students' Union.
- 2 Interest in charity work and compliance, governance or leadership.
